15 YEAR LIMITED WARRANTY

For a period of two (2) years from the date of shipment from a factory recognized distributor, Deflecto Canada Ltd. warrants this flexible aluminum chimney liner to be free from defects in material and workmanship to the original purchaser. During this two (2) year period Deflecto Canada agrees to replace such defective components at no charge.

This warranty shall continue for an additional thirteen (13) years on a pro-rated basis with the proration commencing with the original purchase date.

This warranty is only valid if the product and the related heating system(s) are installed in accordance with their Listings and approved installations. This product and the heating system(s) to which it is connected must also be inspected yearly by a qualified heating or venting technician and the inspections recorded on the reverse of this form. All deficiencies must be remedied and documented at the time of discovery. It is the responsibility of the homeowner to retain this warranty record, and it must be presented in the event of a claim.

Deflecto Canada Ltd. excludes and disclaims any liability for lost profits, personal injury, interruptions of service or for consequential or incidental damages arising out of, resulting from or relating in any manner to this product.

This warranty does not cover defects or damage resulting from abuse, misuse, neglect, lack of reasonable care, modification of attachment of improper components or devices to this product.

The warranties contained in this agreement are in lieu of all other warranties of merchant ability and fitness for a particular purpose.
